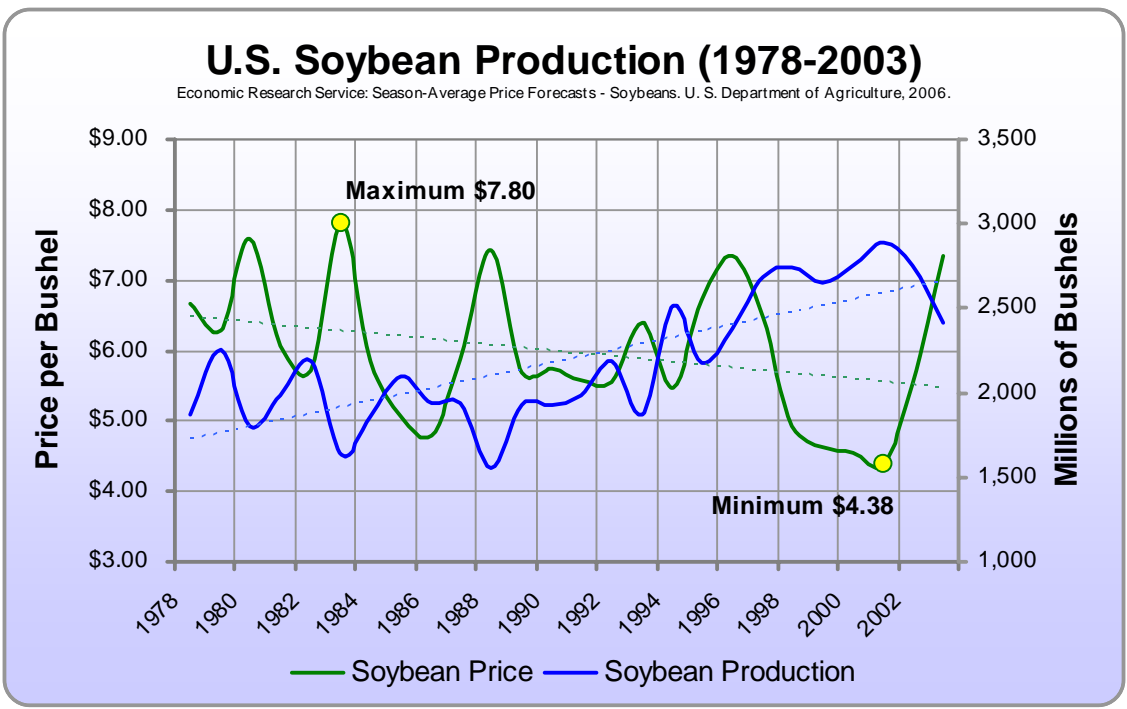


Figure S.3: U.S. Soybean Producer Pricing (1978 – 2003)

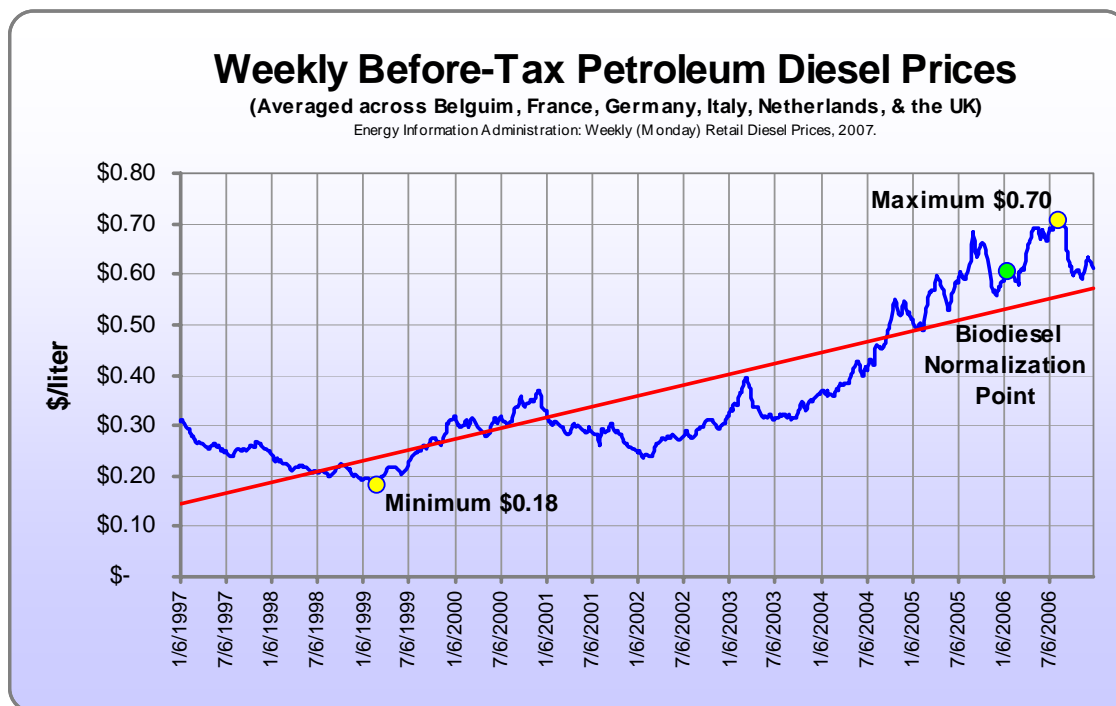


Figure S.4: European Petroleum Diesel Pricing (1997 – 2006)
